

**POLICY REGARDING THE SALE OF PRODUCTS CONTAINING CANNABIDIOL (CBD)
ON WISCONSIN STATE FAIR PARK (WSFP) GROUNDS**

The Agriculture Improvement Act of 2018 (Farm Bill) removed hemp and derivatives of cannabis with extremely low concentrations of THC from the federal government's list of controlled substances under the Controlled Substances Act.

However, the FDA prohibits marketing products containing CBD with claims of therapeutic benefit, or with any other disease claim, without FDA approval. Moreover, the FDA has indicated that it is unlawful to introduce food containing CBD into interstate commerce or to market CBD products as dietary supplements.

Section 94.55 of Wisconsin Statutes allows individuals in possession of a valid license issued by the Department of Agriculture, Trade and Consumer Protection to possess and sell industrial hemp, and the Wisconsin Department of Justice has indicated that license-holding retailers can sell CBD products, so long as it is derived from a state-licensed hemp program and contains less than 0.3% THC.

Therefore, in consideration of the aforementioned information, Wisconsin State Fair Park (WSFP) allows vendors to sell CBD products, so long as the following criteria is met:

- Any products derived from cannabis must fall within the 0.3% or less permissible concentration of THC as set forth in the Farm Bill;
- Vendors and exhibitors shall not sell or distribute on State Fair Park grounds any products containing CBD that the vendor or exhibitor markets/advertises with claims of therapeutic benefit, as a dietary supplement, or with any other disease claim, without FDA approval.
- Vendors and exhibitors shall not sell or distribute on State Fair Park grounds any edible/consumable products containing CBD, including products promoted for animals/pets.
- Any booth or event promoting CBD products must not allow the sale of CBD products to minors nor can they in any way entice, induce or market to minors;
- Vendors and exhibitors must properly secure all required local, state and federal permits. Permits must be provided upon request from any state of Wisconsin or law enforcement agency, including, but not limited to: Wisconsin State Fair Park, State Fair Park Police, Wisconsin Department of Justice, Wisconsin Department of Agriculture, Trade and Consumer Protection and the Wisconsin Department of Revenue.

Event holders, vendors and exhibitors are responsible for awareness of and adherence to this policy and all laws governing this activity as required by local, state and federal authorities. If a vendor or exhibitor fails to adhere to this policy WSFP reserves the right to direct the vendor or exhibitor to remove their CBD products or leave the premises. WSFP also reserves the right to take into consideration an event holders' failure to ensure its vendors and exhibitors adhere to this policy when determining whether to allow such event holder to hold events on State Fair Park grounds in the future.

A reminder regarding other related WSFP policies are as follows:

- WSFP has discretionary authority over who may operate on the grounds, and what products and services they may sell;
- Possession or sale of marijuana or any cannabis product containing greater than 0.3% THC in any form is strictly prohibited;
- State Fair Park will in no way be involved in the promotion or advertising of any cannabis-related retailers or events.
